State Secretary Dr. K.P. Senthamarai Kannan welcomed all the state EC members for the 4<sup>th</sup> State EC meeting of Tamilnadu State Branch and honoured the State president Dr. K.K. Umashankar with the presidential collar.

### Welcome Address by the president:

State president Dr. K.K. Umashankar welcomed all the state EC members and requested the members to maintain the decorum and said suggestions should be addressed only to the president.

State president requested all the EC members to observe one minute silence for betterment of IDA.

### Confirmation of minutes of last executive committee meeting:

State president requested state secretary to details about the mails received by the state office regarding correction of minutes.

State secretary said one mail was received from Dr. Arul prakash of Tirunelveli. State secretary said the detailed reply for the correction has been printed in the minutes at the 8<sup>th</sup> page, Para 3 and requested him to go through it.

Dr. Arul prakash asked why the State EC meeting was not conducted at the venue of IDA state conference at Kodaikanal inspite a requisition mail from the organizers during the EC meeting held at Tiruvannamalai.

State president replied that organizers requested for a state EC to be held at Kodaikanal. It was only said that it will be considered during the venue inspection, as the venue halls were full with scientific activities and it was decided that it will be difficult to conduct a state EC during state conference. So it is conducted now. State secretary said Dr.Arul prakash mail isn't relevant to correction of minutes so it cannot be taken has correction of minutes and requested the floor to pass the minutes. Minutes passed.

### Action taken on minutes:

### State president to detailed about the action taken on minutes:

- Golden jubilee year badminton tournament conducted at Erode in an excellent manner by Erode branch. Around 100 members participated and special thanks to our state president Dr. Umashankar and office bearers of erode branch.
- 4<sup>th</sup> ACDEP programme and Inter-state CDE was organized by IDA-Tamilnadu state in Chennai. The programme was excellently organized by Madras branch and IDA-National President Dr. Puneeth Girdhar, and IDA-Hon. General Secretary Dr. Ashok Dhoble graced the occasion.
- 5<sup>th</sup> ACDEP was conducted by IDA-Tiruvarur branch. Speakers were Dr. Arun Varghese and Dr. Nachiappan. Around 35 members attended the programme. The programme was well organized by Dr. Aravindhan & Dr. Madhan.
- Our golden jubilee year celebration conference and 35<sup>th</sup> IDA-TN state conference was conducted by Madurai branch on 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> Sep 2022. The conference was well organized by COC team of Madurai. Excellent food, hospitality and scientific sessions are the highlight of conference. We wholehearted thank to organizing Secretary Dr. Gururaj ,organizing chairman Dr. Pradeep, Treasurer Dr. Arul Arasu Madurai branch secretary Dr. Prabhakar, Patron Dr. Manivannan and whole team of Madurai. Tamilnadu tourism minister Dr. Mathivendhan inaugurated the conference and all the past president and secretaries of IDA tamilnadu were felicitated. The programme was a huge success.
- Dr. A.V. Arun from Chennai Metro branch has raised a query that at previous meeting it was discussed regarding direct members and branches not maintaining geographic area. What was action taken by state office?
- State president replied that letter has been to sent all the branch presidents and secretaries to maintain the geographic area and to avoid direct membership, he also said this discussion can be continued in the membership status agenda.
- Dr. Thangavelu from south arcot raised a question regarding less attendance at oration and the scientific halls at conference and questioned the organizers and state office bearers for their absence in oration hall?
- State secretary replied that as the inauguration was late and all the members were requested to go to the oration hall. The hall was fully occupied for the chitrambalam oration held at Hall No.1

- Dr. Thangavelu said there was no one from office bearer's side to detail about the bio-data of oration stalwarts and in future this has to be taken care by the state office. He also added the oration stalwarts bio-data should be detailed by State secretary.
- Suggestion was accepted by the state office and by the State EC.
- Dr. G.P. Surendran from Coimbatore also suggested the same thing and requested the office bearers to invite the oration stalwarts member's family to the oration in future. He also said he invited everyone when his branch conducted conference at Coimbatore last year. EC floor accepted and state secretary said in future we will follow the procedure.
- Dr. K. Rajasigamani said it is not duty of state office or organizers to fill the hall for the oration. Its the duty of the members to attend the scientific activities and cannot compel any one to attend the scientific programme. More over youngsters need to be encouraged as speakers and huge crowd cannot be expected when seniors takes lecture. If the lecture is good more members will attend so its waste of time in accusing the state office.

# To discuss about Care and Concern and the membership status of IDA-TN:

State president requested care and concern chairman Dr. K. Chandira Mohan to detail about the current status of IDA-TN and Care and concern scheme.

Dr. K. Chandira Mohan detailed about the Care & concern membership strength is 1213.

Dr. K. Chandira Mohan said we have around 292 state EC members and around 275 members have become care and concern members and that is the great achievement and still more another 17 members has to become care and concern members. We are trying our level best to make all the state EC members as care and concern members.

Dr. A. Thangavelu questioned regarding the extension of time to become care and concern members. He also emphasised to take immediate action and to remove their list.

State president said as many opportunities had been given, it is better to remove them from the list. Dr. Johnson raja mentioned that it is not easy to remove their names because it is constitutionally not valid.

Dr. K. Chandira mohan came with a suggestion that the extension can be given till next state EC meeting. Dr. A. Thangavelu said be strict on the rules and regulation and don't break the resolution made in previous EC and also suggested from the next year starting don't encourage non care and concern members to take the post.

State president appreciated the suggestion given by Dr. A. Thangavelu.

State secretary said as of today only 20 state EC members are not part of care and concern scheme and around 200 Local branch office bearers haven't become care and concern scheme. So its better we can give one more chance for them till next EC meeting. Floor accepted. Dr. Rajasigamani also emphasised the same.

State president said even though state office has accepted all the membership till 31<sup>st</sup> July why there were so many direct members?

Dr. D. Vinola raised a objection that there were so many direct members this time and a pathetic situation that there were are around 26 members from IDA-Salem branch. She also added we cannot accommodate the direct members because till 31<sup>st</sup> July we accepted all the application but they haven't submitted any application or paid their branch share to local branch. She requested head office and state office not to allow them in any branch and don't allow them to vote in the upcoming election.

Dr. Vinola also mentioned that even the payment has been not done by the member and they were encouraged by adjacent branch to become a direct member.

Dr. Rajasigamani said that as state secretary election will take place this year the association is heading towards another legal issue as same like 2014. So he requested not to encourage the direct member to vote in the upcoming election and also requested to cancel the direct membership from head office.

Dr. A. Thangavelu questioned why the direct membership has been encouraged by the head office. It is total confusion for local branch as well as state office.

Dr. G.P. Surendran said he was fighting for this issue for past 20 years but no one supported me and said the direct membership induction will create more confusion in the local branch and state branch. He also added how a member can be accommodated without application, attached documents and the branch share into the local branch. He strongly condemned this attitude.

State president said state office won't encourage the direct membership and also said all this 279 direct members payments has been made by single person, so better not to give them voting rights this year.

Dr. Ravishankar, Dr. K.A. Annamalai from dharmapuri also emphasised the same.

State secretary said we have received this information from head office on first of August that around 279 members has become direct members within a week and requested state office to enquire.

We state office has written a letter to all the 279 members to submit their application and attached documents within 20<sup>th</sup> August to process their membership and also said the date of receiving application will be their enrolment date of their membership. Only 69 applications till date and were received and a written letter has been sent to head office stating that only 69 applications received till 20<sup>th</sup> August and requested head office not to give voting rights for all the direct members from IDA-TN. Head office accepted our request and said they will not add their names in the voters list.

Dr. G.P. Surendran said bring a resolution in the state EC that infuture direct membership should be abolished from head office and no one in tamilnadu should become direct member. He also requested to all the CC members to bring a resolution in the next CC. After a brief discussion, floor unanimously decided not to give voting rights to any direct member from IDA-Tamilnadu.

State president announced that our State EC has decided not to give voting rights to the direct members and he also said resolution also passed for same. Floor approved.

Proposed by Dr. G.P. Surendran, Seconded by Dr. Arunkumar.

# To discuss about the Annual General Body meeting of IDA-TN for the year 2022:

State president said as conference has already been conducted in September its duty of state office to conduct the AGM and they have decide about the venue.

State secretary said as per the constitution state office will conduct the AGM at State secretary town Salem.

Dr. A. Thangavelu raised a question on the planned date for AGM. State secretary said it will be discussed with state president and informed. Dr. A. Thangavelu said as its state secretary election year not to drag the date, it will be good to inform the date soon.

State president said next State EC meeting will be on November 6<sup>th</sup> and Annual General Body meeting will be on December 4<sup>th</sup> 2022. EC accepted.

Dr. Kinsley Selvakumar raised a question why AGM & Election in same place. State president replied its always duty of state office to conduct the AGM and Election and it will be easy for them to carry all the records. Dr. Kingsley Selvakumar raised as another question that president elect also from same place why not to conduct the AGM and election in some other place.

State secretary said that seen Head office conducts its AGM where Hon. Secretary General resides so there is no chance of shifting AGM to any place rather than salem.

State president said AGM will be conducted in salem on December 4<sup>th</sup> 2022 and requested the floor to approve. EC accepted. State president came up with a suggestion of election being conducted online this year. State president elect Dr. Baby John also emphasised the same.

Dr. A. Thangavelu reminded that a resolution was passed at AGM last year that the election can be conducted online. State president replied that there were no election last year and we brought a resolution in AGM considering the strength of IDA-Tamilnadu. He also added most of the speciality association, & IMA has changed their election process to online and IDA can also change.

Dr. Rajasigamani suggested not to think about election in online or offline mode and rather a compromise between the contestants to avoid all this group fights due to election.

State president replied we are also in favour of compromise but state office has to be ready for everything either its online or offline so we need an approval from floor.

Dr. Radhakrishnan requested the EC to conduct the election online. Dr. Surendran also emphasised the same and majority of the members supported for online election.

State president elect Dr. Baby John said since the present state secretary is contesting for the state secretary post so its better to conduct the election online. If it is offline it may favour the state office, so he opted for online and he also said elections should be conducted online in future also.

State secretary mentioned that since he belongs to salem and he is to contest for the state secretary election, he is ready for any option whether it is online or offline, which ever floor decides.

Dr. Johnson Raja said he respects the decision taken by the floor and accept for both options. Once again Dr. Rajasigamani stressed for an compromise formula and requested state president to form a committee.

State president said a new committee will be formed to conduct the online election and also for the compromise and announced the name of committee member. Floor unanimously accepted all the committee and accepted to conduct election online.

#### Any other matter:

State secretary said we have received a legal notice from Dr. Mathan Mohan & Dr. G.R. Karthikeyan to allow them and all the direct members of IDATN to vote in the forth coming election.

State secretary said both the members were violated the constitution and instead of going for arbitration they went to the court. He also added that in the 2017 AGM at Namakkal it was

decided that members without following the constitution and directly going to the civil court will be suspended immediately. In this situation state secretary wanted the EC decision.

Dr. Rajasigamani suggested the state EC to forward the letter to disciplinary committee for further action.

State secretary said the legal notice will be forwarded to disciplinary committee and the committee will take final decision.

State president thanked all the EC members and adjourned the meeting.
